

Elizabeth Warren's call to disband tech giants is a step in the right direction

Democratic presidential candidate and Senator Elizabeth Warren argued in a blog post on Friday that "it's time to break up Amazon, Google, and Facebook." The reason, she says, is because they have become such large monopolies that they're stifling competition from smaller startups and therefore impeding opportunities and innovation. Warren's proposal would ban companies with \$25 billion or more in annual revenue from owning both a platform and companies that participate on the platform -- so Google, for instance, would have to split its search engine from its ad business. Warren also said she would reverse mega mergers, like Facebook's ownership of WhatsApp and Instagram, the merger of Amazon with Whole Foods and Zappos, along with Google's acquisition of companies like Waze. Sen. Warren is right that the business monopolies these companies enjoy are bad for other American businesses and ultimately reduce the choices of consumers. But there's another kind of power these tech companies all have that is an even bigger threat: their monopoly on information. Warren's proposal doesn't fully fix this larger problem. First, these tech companies largely determine what we find on search engines or news feeds when we search for information to make decisions -- like who to vote for or where to seek medical treatment. According to the Pew Research Center, nearly 90% of Americans use the Internet. As Sen. Warren notes in her proposal, Google and Facebook own the sites that receive over 70% of the traffic on the Internet. So they certainly have a monopoly on the information Americans access. And they have structured their algorithms so that the information people see on their sites is at least partly determined by their own business interests. For example, companies and politicians who buy ads jump to the top of Google search results, regardless of whether a person searching for information online might be better served by seeing other sites first. In a 1998 paper, Google's own founders, Sergey Brin and Lawrence Page, highlighted this conflict when they noted that if someone searches the words "cellular phone" on a search engine that sells ads to cell phone companies -- like Google -- the search engine would have incentives not to show a study about how cell phones dangerously distract drivers first.Sen. Warren's proposal to have the Google search engine split off from its ad business would only partially solve this problem. Most people don't scroll very far down search engine results so if we want Americans to be well informed and to easily access a broad spectrum of information when they make important decisions, we need laws that prevent search engine companies from designing algorithms to favor their advertisers or information that serves their own political interests. Second, big tech companies have vast troves of personal information -- from the medical symptoms we search for on Google to the pictures of our kids that we post on Facebook. And it's clear after hacks and other unintended breaches that they aren't very good at safeguarding it. In October, for example, Google announced it would shutter its social network Google Plus after admitting that a software problem exposed the personal information of up to half a million of its users to outside developers. Another bug, which was fixed after six days, exposed user data from a shocking 52.5 million accounts. Sen. Warren argued that reversing some of the mergers she seeks to break up would "put pressure on big tech companies to be more responsive to user concerns, including about privacy." She's right that more competition could result in new startup companies that better protect personal information, which could put market pressure on companies like Google and Facebook to improve their own security controls. But what's also needed is for government regulators to oversee how all this data is stored to ensure that it's better protected. Sen. Warren, who created the Consumer Financial Protection Bureau to protect Americans from financial institutions, would be well placed to propose a regulatory structure for technology companies. In addition to more safeguards from unintended breaches, Americans should have more choices about what companies like Facebook and Google do with our data. In December, for example, the New York Times revealed that Facebook had been sharing the data of its users with other companies, including Amazon, Netflix, Spotify and even foreign entities like the Chinese telecom company Huawei and Russian search giant Yandex. Sen. Warren's proposal wouldn't allow large tech companies to share user data with third parties. That's a great first step, but it still doesn't give Americans enough choices about how their data is harvested and used. Facebook, for example, gathers user data internally which it uses to sell ads to third parties. Last year, Cambridge Analytica -- a company the Trump campaign hired during the 2016 presidential election -accessed user data without permission. That data was then used to create "psychographic profiles" of users to predict their voting behavior. Even if third parties couldn't access such data anymore, nothing in Sen.

First, one should be clear that the listing process is a symbolic move. The JeM is already a proscribed organisation and that hasn't stopped it from launching dastardly terrorist attacks on Indian soil. The Lashkar-e-Taiba (LeT) chief, Hafiz Saeed, too, features in the United Nations sanctions list. However, he continues to enjoy all kinds of freedom in Pakistan and has even floated a political party that contested the 2018 national elections. The listing, therefore, itself wouldn't have achieved a great deal.

Second, China responds to incentives. At the Financial Action Task Force (FATF) summit in February 2018, it agreed to grey listing of Pakistan in return of being offered a vice-presidency of the inter-governmental body. India

China has once again decided to put a obviously did not have an equivalent offer to make in exchange for Azhar's listing. New Delhi needs to find a range of bargaining options with China in the future. The options could be economic (access to Indian markets, tenders, etc.) as well as political (affecting Tibet, Taiwan and Xinjiang).

Third, India needs to realise the limits of its relationship with China. The informal summit in Wuhan in April 2018 was aimed at the two leaders - Prime Minister Narendra Modi and President Xi Jinping

understanding each other's concerns. Either our concerns about Pakistanbacked terrorism weren't clearly communicated to him or Mr Xi simply chose to ignore them. In either case, the Wuhan exercise seems to have failed. Not just Pakistan-backed terrorism, China has not yielded ground on anything else (from trade imbalance to India's membership in the Nuclear Suppliers Group). At a time when China was facing economic pressure from the US in the form of a tariffs war, North Korea was increasingly moving out of Beijing's shadow and Australia was making noises about China's interference in its domestic politics, the Wuhan summit only helped remove the pressure on Beijing from one front altogether. India needs to add a dose of reality to its China relationship.

Ayodhya mediation: The process may not result in an amicable conclusion

With a representative suit such as this, where the parties are not claiming the property for their personal use and benefit but on behalf of larger communities and interests, valid questions can be raised as to whether such a dispute can be settled through mediation at all.

Can the Babri masjid title suit be settled through a court ordered mediation? The strictly legal answer provided by the Constitution and arrive at a binding or even corporate disputes. bench of the Supreme Court (SC) is: Yes. There is no legal bar to the SC referring the appeal from the Allahabad High Court mediation and, in the hands the wisdom of the mediator judgment to a panel of three mediators (notwithstanding the problematic inclusion of Sri Sri Ravi Shankar). He has also gone on the offensive over Modi's economic record, with Congress state wins attributed to the prime minister's perceived failure to help impoverished farmers and create jobs.In the 2014 elections, 830 million people were eligible to vote but only 550 million cast their ballots.







UN members warn of 'other actions' as China blocks bid to list Masood Azhar as global terrorist

The diplomat spoke on condition of anonymity to give a sense of the feeling of other members of the Security Council after China blocked the move to designate Azhar a global terrorist.

(By a Staff Reporter) - Some permanent members of the UN Security Council plan to "pursue other actions" to counter China's continued opposition to designating Jaish-e-Mohammad founder Masood Azhar, a Security Council diplomat said Wednesday, stressing the case for listing the Pakistan-based terrorist was "undeniable".

The diplomat did not elaborate but other UN officials familiar with the rules and regulations of the listing of terrorists by the UN said the stalled designation proposal can be escalated to the Security Council itself now, which would be an unprecedented move and a "public" rebuke of China, which will be forced to "defend its defense of a well-known terrorist in full public view". Christchurch Attack Suspect had white-supremacist symbols on weapons

(By Our Staff Reporter) The suspected perpetrator of a massacre at two mosques in New Zealand displayed white supremacist symbols during the deadly assault that killed 49 people and triggered heightened security at mosques around the world. The attack in Christchurch, the worst mass shooting in the nation's history, shattered the illusion that New Zealand was one of the few countries beyond the reach of global terrorism.The carnage, described by New Zealand's prime minister, Jacinda Ardern, as one of its "darkest days", prompted prayers and vigils around the world, and revulsion that live footage of the atrocity was allowed to circulate on social media. Ardern said she would consider a total ban on semi-automatic firearms after the alleged gunman obtained to the president of the United southern district of New York five guns legally. "I can tell you one thing right States, it comes as a jolt. "I used (SDNY) that he led for more than now: our gun laws will change," she told reporters.

> Christchurch remained on lockdown on Saturday as the country's security threat level was raised from low to high. Mosques across New Zealand and in other countries were warned to be vigilant. In the UK and the US, police stepped up patrols in areas with large Muslim populations and around places of worship in direct response to the attack. Responding to the attack on Friday, the UN secretary general, António Guterres, warned there was an urgent need to tackle Islamophobia across the world. A man in his late 20s will appear in court in Christchurch on Saturday morning,

charged with murder. Police did not name him or two other suspects who were being questioned, but Brenton Tarrant, a 28-year-old Australian man, identified himself as being behind the attack.

Some witnesses criticised the emergency services for being slow to respond to the shooting, claiming it took up to 20 minutes for the police to arrive on the scene in the largest city in the country's South Island. The attack, launched during Friday prayers when both mosques were packed, was livestreamed via a camera strapped to the perpetrator.

Horrific images of bloodshed and people desperately trying to evade the gunman were copied and shared on social media sites including YouTube, Facebook and Twitter, which struggled to remove the footage. Mainstream media organisations were criticised for hosting clips. The gunman arrived at Al Noor mosque at 1.40pm, opening fire on about 400 people. He killed 41 people before driving four miles to the Linwood Islamic Centre, where another seven people were shot dead. One of the 48 people injured in the attacks later died in hospital. A bomb disposal team was called in to dismantle explosive devices found in a stopped car. At Al Noor mosque, Khaled Al-Nobani said a man entered with two rifles, one a "pump-action [gun]", and "started shooting everyone - young people, old women". He added: "He shot the first one on the gate, two people in the corridor, and go inside started shooting everyone." One man was killed in front of his three children, Al-Nobani said.

Ethiopian air crash investigators begin black box analysis

analysing the black box data recorder from Ethiopian Airlines flight 302, amid reports that the plane wreckage suggested similarities with a previous disaster involving the Boeing 737 Max jet. Accounts have also emerged of communications between the plane and air traffic control, in which the pilot is said to have asked in panicked tones to turn back three minutes into the flight, as the 737 Max dipped and climbed. The black box recorder, which arrived in Paris showing some external damage, is being reviewed by French aviation experts at the request of Ethiopian Airlines. French authorities have said it was unclear what data could be retrieved to shed light on Sunday's crash, which killed 157 people outside Addis Ababa. It is likely

Air crash investigators have begun to be several days before any interim findings are released, according to Ethiopian Airlines chief executive Tewolde Gebremariam. Evidence gathered by investigators at the scene of the crash, according to two sources cited by Reuters, includes a piece of the plane's stabiliser, which was set in an unusual position - potentially suggesting similarities with the Lion Air crash off Jakarta in October. Gebremariam said there was a "clear similarity between our crash and the Lion Air crash." Inquiries in Indonesia have focused on how an automated system used the stabiliser to pitch the nose down, against the pilots' commands. The US Federal Aviation Administration (FAA) and Boeing declined to comment on the claims.



"This is a case where [the parents] flaunted their wealth, sparing no expense to cheat the system so they could set their children up for success with the best money can buy," Joseph Bonavolonta, from the FBI's Boston field office, said in a Tuesday news conference.

Most of the students didn't know their admission was due to a bribe, authorities said, but in some cases, the children and their parents took part in the scheme.

"Singer would accommodate what parents wanted to do," Lelling said, adding that it "appears that the schools are not involved."

The scheme allegedly involved extensive coordination with parents. Lelling said Singer had a knack for making fake credentials look realistic enough to avoid inviting close scrutiny. The children's parents would allegedly pay a specified amount of money, fully aware it would be used to gain college admission. The money would then go toward an SAT or ACT administrator or a college athletic coach, who would fake a profile for the prospective student - regardless of ability, according to the charging documents.

"There can be no separate college admission system for the wealthy and there will not be a separate criminal justice system either," Lelling said. "We're not talking about donating a building so a school is more likely to take your son or daughter, we're talking about deception or fraud." On a call with one parent, prosecutors said, Singer described the business simply: "What we do is help the wealthiest families in the U.S. get their kids into school. ... My families want a guarantee."

Singer would help his clients' children by having another individual take SAT or ACT tests on the youngsters' behalf, officials said. Parents would allegedly pay up to \$75,000 for each test and wire money to "charitable accounts."

Yang said his aim is to enhance the jet's "informatised warfare capability and weapons" or the use of cutting-edge communication technology in modern warfare.

"All related work is being carried out," Yang was quoted as saying by the nationalistic tabloid Global Times at a press conference held on the sidelines of China's ongoing Parliament session.

The JF-17, or the FC-1, is a single-engine multi-role light fighter jet jointly developed by China and Pakistan for export, according to the website of the Aviation Industry Corporation of China. Yang added that the development and batch production for the JF-17 Block 3 aircraft were going on simultaneously.

"The third block will see the JF-17's informatised warfare capability and weapons upgraded," Yang said.

Pakistan, the main user of the JF-17, could further share information between the fighter and other platforms, taking advantage of the whole combat system to effectively defend against strong

opponents like India, a military analyst Wei Dongxu was quoted as saying.

Wei explained how the upgraded version would be put to use against the IAF.

"JF-17 Block 3 is expected to be fitted with an active electronically scanned array radar, which can gather more information in combat, enabling the fighter jet to engage from a farther range and attack multiple targets at the same time. A helmet-mounted display and sight system could also allow pilots to aim whatever he sees," Wei said.

Once the new upgrades are ready, they can be fitted on the airframe very fast, ensuring a quick delivery time, Wei added. According to the tabloid, the JF-17 is often described by its manufacturer and military observers as an advanced but also a cost-effective fighter.

"It is currently contending with India's Tejas and South Korea's FA-50 in Malaysia's new fighter jet purchase plan, with the JF-17 being the most competitive option," Wei said.

Myanmar and Nigeria have reportedly purchased the Chinese-Pakistani warplane.

Some also complained that the News Feed was not refreshing at all. WhatsApp is also partially down for some users as they are unable to access some key features such as voice notes. Facebook said it was aware about the issues with its applications and was working to resolve the problem.

DDoS, also known as distributed denial-of-service, attack is when multiple devices flood the bandwidth of a targeted system, ultimately causing it to crash.





The first two episodes, directed by Akhtar, set the mood - the slow, languorous shots, especially, do a clever flip, gifting its mainstream premise an art-house robe - but, at the same, also slips up: the expository dialogues jar; the longish voiceovers by the detached photographer Kabir Shrivastava), tells a story of (Shashank Arora) spout tired truisms; some crucial plot turns, made predictable by on-the-nose foreshadowing, seem unconvincing.
